The diesel particulate filter was stolen from underneath the bus, destroying sensors, wiring and pressure filters, causing extensive damage to the bus. We are working with Community Link to install security cameras on their parking lot. All information has been turned over to our insurance company and the bus has been repaired. Since then, 2 other buses owned by Community Link have been vandalized at Community Link with thieves trying to take the catalytic converters.

Nollman-Hodge also reported on a member of the scheduling/dispatch team being involved in a serious car accident on Monday, with a long road to recovery ahead of her.
