## CONTRACTS

Public Aid - Nollman-Hodge reported receiving nothing since last board meeting.
Bryan Manor - Nollman-Hodge reported signing a new yearly contract with Bryan Manor for transportation in Centralia and Mt. Vernon.

IMRF ACCELERATED PAYMENT - Copeland reviewed the information that was included in the packets. Stratemeyer suggested going in to closed session during the board meeting to discuss. Motion to take to the full board by Stratemeyer, seconded by Boyd. All aye. Motion carried.

PCOM - Nollman-Hodge stated that the PCOM report was included in the packets and asked for questions. Motion to send to the full board for approval by Boyd, seconded by Stratemeyer. All aye. Motion carried.

WAGE/SALARY INFORMATION - Nollman-Hodge included in the packets the CARES Funding Employee Appreciation for Fall/Winter 2020 and the Wage and Salary plans for Spring 2021. Copeland asked for more information on all job classes, Jones asked if a work session on wages and salaries was still something that will be scheduled for the future and Copeland replied it was, but more information was needed before that would be scheduled and to keep it on the agenda.

BUS 817 - Nollman-Hodge reported that the lease with CTD for bus 817, a 2015 Chevrolet 27 passenger bus was just renewed for 1 year at $\$ 825$ per month. August 2021 will be the end of the lease agreement; lease will then become $\$ 1$ thru CTD.

OTHER - Nollman-Hodge stated that they have been dealing with fraudulent SCT checks being presented for payment, police report has been made. A new program has been implemented with Midland Bank to safeguard against fraudulent checks drawn on our account.
