

South Central Transit offers safe and reliable shuttle transportation with predetermined stops in Centralia, Irvington, Richview and Ashley with transfer services available to Mt. Vernon or Nashville.

Ashley Park, Ashley IL, Times Square Mall (near Dunham's Sport) and Bus Stop Sign (1120 Veterans Memorial Dr) will serve as transfer stations in Mt. Vernon and will provide passengers the ability to transfer to SCT Intra City buses serving the city of Mt. Vernon.

SCT Intra-city shuttles make frequent stops at **Greyhound, Mt. Vernon** (Jefferson Route) and **Amtrak, Centralia** (Cubs Route). These services are available by using Inter-city (county) shuttle routes offered in designated counties served by SCT with connecting services to Intra-city shuttle routes that operate from 8:30 a.m. to 5:30 p.m. M-F inside the city limits of Mt. Vernon and Centralia.

SCT Bus Stop signs are located at transfer locations and serve as the designated bus stops. This route will deviate up to 3/4 mile to pick up passengers who are unable to access a shuttle stop.

A 24-hour notice is required to reserve a seat for route deviation.

SCT offers "Money Cards" for use with all fares instead of passes / tickets. Money Cards can be purchased from drivers, are available in various denominations and are valid for use with all services provided by SCT including all SCT Shuttles. **Money Cards must be presented to the driver upon boarding for validation and expire only upon the entirety of it's purchased value.**

- **Limited seating available and will be on a first come first served basis.**

Effective 3/28/2016 - Any client transferring shuttle buses at Ashley Park to complete their trip will be required to use an SCT Transfer Ticket. Clients must request Transfer Tickets from the driver when paying their shuttle fare.
